Feast in the Woods—Back For Seconds will be held at the Texas Conference of Clubs *Buzzards' Peak* landsite. Located near Cameron, Texas, Buzzards' Peak is convenient to the Dallas-Fort Worth, San Antonio and Houston metropolitan areas. The land site at *Buzzards' Peak* is 32 acres with roughly seven acres cleared and developed for camping, games and parking. The site includes indoor shower facilities, sanitary facilities, a fully functional cooking area, and a large covered pavilion.

The campout fee is \$75 and includes a Friday evening meal, Saturday breakfast, lunch and dinner and Sunday morning breakfast. There is limited space available in the bunkhouse for \$25 for the weekend. Electrical hookup is available at most tent and RV sites; parking for pop up campers and RVs is \$25 for the weekend.
